

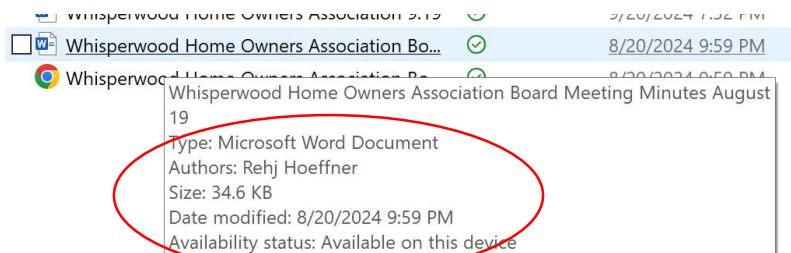

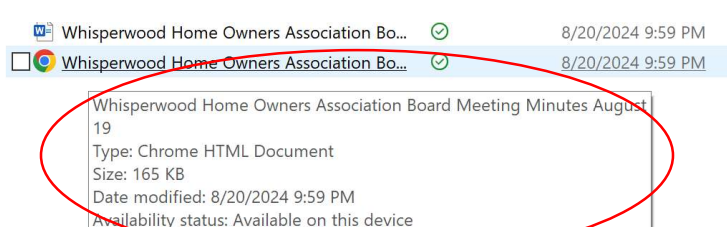

Correction to the Minutes:

Under Pool/Pool Committee and related issues it reads:

"It was reaffirmed that all expenses related to the pool would require board approval PRIOR to purchase."

It should have read:

"It was reaffirmed that all INVOICES related to the pool should be run through the board."

In other words, if monies are spent on the pool, the original invoice should be presented for payment. The CPA has informed us that some checks are cut without the expenses being itemized so they are unaware of how to categorize them. This can only happen if the original invoice is presented at the time the check is actually cut.

Note: I typed up the Meeting Minutes from Priscilla's notes, thus the reason for the confusion.
